FIRST AID INTERVENTION

First aid in case of:

Contact with eyes: remove contact lenses if used, wash thoroughly and thoroughly with water; in case of persistent irritation, seek medical attention.

HANDLING AND STORAGE

Manipulation

- o Carefully follow the instructions on the packaging or on the enclosed leaflet.

Storage
