### HANDLING AND STORAGE

Store in dry and well-ventilated places.

Recipient under pressure. Keep away from sunlight and temperatures above 50°C.

Keep away from flames, hot objects, or operating electrical elements. Store in a non-smoking, well-ventilated place.

Operate in well-ventilated rooms. The work environment must be sufficiently ventilated, with mechanical air exchange (Art. 9 DPR 605/56).

Spray for short intervals of time, avoid long vaporization. Do not spray on flames or hot objects.

After use, do not puncture or burn the recipient.

### PERSONAL PROTECTION/EXPOSURE CONTROL

Do not spray on irritated skin.

Do not use in ways other than those specified by the manufacturer.
